Dear Customer,

Our company policy on seed certifications, as a requirement of any quality protocol, is as follows:

1. All our seeds belong to the category of Standard Seeds, complying with the production, quality and health standards laid down by the European Economic Community in accordance with Regulation of the Ministry of Agriculture, Fisheries and Food: Article 18911 of 01/07/1986 on Technical Standards for Control and Certification of Vegetable Plant Seeds (EEC Council Directive 70/458), published in Official State Gazette (BOE) no. 169 on 16/07/1986 (Annexes II and VII) and subsequent amendments of the abovementioned Regulation (Royal Decree 323/2000 of 3 March 2000, Official State Gazette no. 55 dated 4 March 2000).
2. In the event that the seed has been treated with a specific product, it will be indicated on the packaging in accordance with current regulations (see Annex VII).
3. Nunhems guarantees that it complies with the abovementioned Regulation and hence it will not issue individual certificates per batch and/or variety.
4. Information on the variety name and distributor details are clearly indicated on the sales invoice. With regard to the batch number, this is given on the delivery note.
5. The description of the variety and its potential resistances are given in the company's commercial material.
6. The official Dutch body Naktuinbouw (NAL) has certified Nunhems with No. H 439, enabling the company to carry out all the quality control laboratory tests relating to seed analyses and their state of health.
7. Finally, we would like to confirm Nunhems position with regard to genetically-modified seeds (GMOs):
 - Nunhems has never supplied its customers with genetically-modified horticultural seeds.
 - Nunhems does not currently have any varieties of genetically-modified horticultural seeds, and is therefore not currently supplying any such seeds.

- No genetically-modified seeds will be delivered to our customers without previously having notified them of this fact and having received their consent to this delivery.
- Our seed production complies with the production standards of the country in which this production takes place, including the stipulated isolation distances. Nunhems is committed to the optimum management of its products, and firmly supports and has signed its commitment to the industry management initiative Excellence Through Stewardship, details of which can be found on the following website: www.excellencethroughstewardship.org
- However, due to the free movement of pollen, and since it cannot be ruled out that material containing recombinant DNA or material that may have been modified by optimizing the specific genome might be grown by third parties in seed production areas, mixtures with this material cannot be entirely prevented. Consequently, it cannot be guaranteed that the batches of seeds comprising this delivery are free from all traces of material containing recombinant DNA or material that may have been modified using targeted genome optimization.
